The purpose of the grants is to foster international cooperation in cultural, scientific and technological fields, to promote Italian language and culture and to support Italy's economic system in the world.

Deadlines

Applications must be submitted by 14h00, Central European Time on 09 June 2022

Who can apply?

- Applicants not residing in Italy and Italian citizens living abroad;
- Must hold an appropriate academic qualification required to enroll at an Italian University or Institute;
- Applicants for Master's Degree, Higher Education courses in Arts, Music, and Dance and Italian Language and Culture courses should not be over 28 years old by 09 June 2022 (with the exception of renewals);

- Applicants for PhD Programmes should not be over 30 years old by 09 June 2022 (with the
 exception of renewals);
- Applicants for Research Projects under academic supervision should not be over 40 years old by
 09 June 2022;
- Applicants for Italian culture and language courses must provide a certificate of Italian language
 proficiency. The minimum level required is B2 within the Common European Framework of
 Reference for Languages (CEFR). For information please visit: Common European Framework of Reference | Europass

Language proficiency

- Applicants must provide a certificate of their proficiency in Italian language. The minimum level required is A2 within the Common European Framework of Reference for Languages (CEFR)
- Proof of efficiency in Italian is not required for courses taught entirely in English. In this case
 applicants must provide a language certificate of their proficiency in English. The minimum level
 required is B2 within the Common European Framework of Reference for Languages (CEFR)

What the Grants offer

- Grantees may be exempted from the payment of enrollment and tuition fees depending on the policy of each university.
- Grantees will be covered by a health and medical/accident insurance contracted by MAECI for the entire duration of the grant.
- Grantees will receive a 900 Euros monthly allowance (approximately R15 314.46) on a quarterly basis, which will be paid in their Italian bank account.
- Anything not stated above must be covered by the recipient him/herself, including international airfare.
- Grants are awarded for a period of study from 01 November 2022 to 31 October 2022.
